10. HIGHWAY GULLIES MAPPING INITIATIVE (placed on the agenda by Cllr David Coyle)

To consider a proposal for a coordinated initiative involving ATC Ward Councillors in identifying and mapping problem highway gullies within their wards, to be submitted collectively to Northumberland County Council (NCC) Highways for action. To recommend that Ashington Town Council approves and supports the implementation of the Ashington Highway Gullies Mapping Initiative as a proactive and collaborative approach to improving highway drainage and community satisfaction (enc)^{vi} To agree that the Council:

- Monitors progress and reports outcomes to a future meeting.
- Considers repeating the exercise annually if successful.
