11.ASHINGTON REGENERATION

To agree to write to Cllr Glen Sanderson, Leader of Northumberland County Council, to request an update on the status of the Ashington Town Centre Regeneration Project. Specifically, the Council notes that the £600,000 project to revitalize the town centre, Ashington North-East Quarter Redevelopment (Phase 2), appears to now be behind schedule and funding has been temporarily reallocated to other strategic projects in 2023/24 (enc)^{iv}

The Council agree to seek clarity from Cllr Sanderson on:

- a) The specific delays that have impacted on the project timeline.
- b) The reasons and contributing factors for these delays.
- c) A promise that the funding will be protected in the Strategic Regeneration Projects budget 2024/25.
- d) Reassurance that delays will not impact on external funding achieved.
- e) A revised project timeline and expected completion date.
