## FC23/072 ASHINGTON REGENERATION

Members were provided with a further update that all Town and County Cllrs were invited to an Ashington Regeneration Programme update on Friday 8th December. Members were pleased to have received the invite, but upheld the proposal, and **AGREED** to write to Cllr Glen Sanderson, Leader of Northumberland County Council, to request an update on the status of the Ashington Town Centre Regeneration Project.

It was discussed that whilst there is some understanding of the complexities of managing a multi-year regeneration program, Cllrs remained concerned by the lack of transparency and communication surrounding the delays to this critical £600,000 investment in the town centre. Furthermore, the project's new unfinished timeline and the temporary reallocation of funding to other strategic projects has raised doubts over whether the intended outcomes will still be achieved by the March 2025 target.

Cllrs were unanimous in their disappointment about this and past investment plans, which have either stalled or been revoked in Ashington. Members voiced distrust and agreed that open reassurance was needed from the County Council that this project remains a priority and that the reasons for the delays are justified.

Members agreed that a firm revised timeline would provide helpful clarity, especially noting that the Ashington North-East Quarter Redevelopment (Phase 2), appears to now be behind schedule and funding has been temporarily reallocated to other strategic projects in 2023/24.

The Council AGREED to seek clarity from Cllr Sanderson on:

a) The specific delays that have impacted on the project timeline.
