Please give a brief description of your group/organis	ation, and your priorities for the current year:

We are a registered charity providing leisure facilities for the community of Ashington, in particular facilities and activities for elderly people.

We have over 100 members who take part in activities such as snooker, billiards, darts, indoor table games. They can also occupy themselves in our community garden by either taking part in maintenance duties or just relaxing.

We have a games/meeting/tv room, and extended kitchen/eating area.

We arrange monthly coffee mornings, frequent Music/Bingo/Quiz Nights, exhibition matches and excursions.

We run regular internal competitions and have five snooker/billiards teams taking part in local leagues.

We have separate groups who look after painting activities and gardening activities.

We have established strong links with the community, and with other similar groups within the area.

Our priorities for this coming year are firstly to complete our extension. This will give us a much bigger room in which to hold events for larger audiences. The extra space will also allow us to increase our range of activities. All of this extra activity will also increase our membership and our visitor numbers.

We are also reconfiguring the inside of the building to create a larger seating area.

At the moment, it is anticipated that this extension project will all be funded with grants we have received, although we aren't sure what obstacles lie ahead of us. Work has only just started (March 25<sup>th</sup>, 2024) but already we have had issues with foundations having to go deeper than expected, and with the removal of the outer skin of the existing building....old windows had been boarded over and proved to be more difficult to remove and strengthen to reposition the front door.

We see this extension as the last project in what has been a very busy and successful last five years for us.

Our three snooker tables are in constant use and they are in constant need of maintenance.

Equipment around the tables has not been replaced for a number of years, so we intend to upgrade many items this coming year.

We would like to replace three sets of snooker balls, two sets of billiards balls, three cue extensions and three table covers.

This list would cost well over £1,000 so a grant of £500 from The Town Council would be put towards that.

At the moment we are looking very healthy from a financial point of view, as the enclosed accounts show. We like to think that is because of our shrewd financial control and sound ongoing financial model.

We'd like the council to consider the following, please. In our current set of accounts:

- £8,000 is ring-fenced from grants received for energy costs
- £2,100 is ring-fenced from grants received for garden club purchases
- £60,000 is ring-fenced from grants received for the extension
- £10,000 is ring-fenced from our reserves to deal with unexpected costs during the extension project.


We fully-understand if the council feels we have enough of our own cash, and cannot support us with our application. However, we respectfully point out that we've already encountered around £5,000 of unexpected costs as we start the extension.

We very much hope we don't encounter any more unforeseen problems, but we really won't know what state our reserves will be in after the job is completed.

Therefore, we have applied for this grant during what is an exciting, but uncertain few months for us.
