

# ASHINGTON YOUTH COLLABORATION MEETING

## Meeting Report

## 1. WELCOME AND INTRODUCTIONS

The meeting convened at 2:00 PM at the YMCA South View, bringing together key partners working with young people across Ashington to share updates, coordinate activities, and explore collaborative opportunities.

---

## 2. PARTNER UPDATES

Partners provided updates on current activities, recent developments, and ongoing initiatives:

### Community Safety Team

- **Hirst Park Anti-Social Behaviour:** The issue of anti-social behaviour involving fireworks in Hirst Park has now ceased following targeted intervention work.
- **Improved Lighting:** Lighting at the Hirst Park pavilion has been addressed, creating a brighter, safer environment around the facility.
- **Town Centre ASB:** Anti-social behaviour around Asda, Ashington Leisure Centre, and Station Road has been addressed. Young people involved have been identified and their contact information has been passed to social services for appropriate support and intervention.

### YMCA Northumberland

- **Jamming in Jammies Event Success:** The overnight event, which ran from 7pm to 8am and featured a silent disco and various activities, was highly successful with 17 young people attending.
- **Increased Attendance:** The YMCA continues to see new young people attending almost daily, likely attributed to the introduction of new music sessions which have proven popular.
- **Upcoming Programme:** Ultimate Pulse sessions are scheduled to begin in the new year, providing additional youth engagement opportunities.

### Beyond Youth

- **Ashington Nativity - Follow the Star:** An all-age interactive Christmas celebration planned for Saturday 20th December, 3:00pm-6:00pm. The event will include:

- Crafts, stories, carols and lights starting at St Andrew's Church (3:00pm)
- A Walk Through Ashington with carols and children's activities
- Nativity performance at Holy Sepulchre Church (5:15pm)
- Refreshments provided

### **Northumberland College**

- **Community Engagement Goals:** The college is actively seeking to increase community engagement and strengthen links with other organisations and services.
- **Youth Collaboration Participation:** Attendance at meetings such as the Youth Collaboration Meeting represents part of their networking strategy.
- **Police Liaison:** Jen Baxter will coordinate with police regarding the relationship between law enforcement and young people in Ashington.
- **Safeguarding Session:** A police officer will visit the college to deliver a safeguarding presentation to students.

### **Ashington Neighbourhood Policing Team**

- **School Communications Network:** Currently establishing improved communication channels with local schools through a dedicated network.
- **Public Perception Work:** Ongoing efforts to improve public perceptions of policing in the community.
- **Anti-Social Behaviour Trends:** ASB incidents remain at low levels following the spike during the Guy Fawkes period, indicating successful intervention strategies.

## **3. ASHINGTON TOWN COUNCIL UPDATE**

Councillor Ball provided an overview of the **Community Chest Fund**

- **New Panel Established:** A newly constituted panel is now in place to assess applications.
  - **Pre-Christmas Decisions:** All outstanding funding applications will be decided before the Christmas break.
  - **January Application Window:** The next funding application window will open in January 2026.
  - **Match Funding:** The panel will also consider match funding arrangements to maximize the impact of grants awarded.

- Currently open for applications supporting community safety projects and initiatives

3. **Youth Engagement Growth:** Positive trends in youth attendance at YMCA and other venues, indicating successful programming.
4. **Funding Awareness:** Partners were made aware of multiple funding streams to support youth work.

5. **Improved Coordination:** Strengthened relationships between police, educational institutions, and youth services.
  6. **Forward Planning:** Clear actions identified to enhance partnership working and address emerging needs.
