## **Neighbourhood Services**

Ryan has been working hard to maintain and add some additional features to the Gateways and the Mining Wheel feature. These are looking impressive, some of which we have the weather to thank, but mainly Ryan's eye for what looks good. Rocks from Doves Corner and St John's have been repurposed and the features really stand out. Bulbs are also looking splendid this year. Gary has contacted Ashington Camera Club to ask if some photography could be done when they are looking so good in the sunshine.

The Memorial Garden has had a light-touch tidy but has been deliberately left as it will be redeveloped as part of the regeneration (further later in the report). All town council assets have had their first weed spray of the season.

Maintenance at play areas continues. Kompan have now returned to fix the roundabouts at Alexandra Road and Orchid Meadows; this was completed under guarantee.

Play Area signs are now ready for collection from Spotty Dog Signage. In line with our commitment to utilise in-house resources whenever possible, these signs will be installed directly by Mark and Ryan rather than outsourcing to external contractors.

Our Neighbourhood Services Officers have dedicated their exceptional skills to various town projects, which has temporarily shifted focus away from routine tasks such as bus shelter cleaning, as has occurred in previous periods. The next scheduled clean will be carried out by a local contractor. This presents an opportunity to consider establishing regular contracted cleaning schedules going forward—a full report with recommendations will be presented in due course. Our priority remains making the best use of our team's valuable skill sets, and the recent project work highlights the outstanding work Mark and Ryan are able to deliver across the town.

## **Allotments**

Asbestos was successfully collected on Monday 7th April from Seaton Hirst and High Market by our approved contractor.

Bushes have been cut down by Bernicia near Seaton Hirst Site, but we await a further update regarding the hedge line.

Hedge and tree trimming has commenced at North Seaton Colliery site and will continue throughout the week. Please note that particular care will be taken and all hedges and trees will be checked for nests by the contractor. Courses are booked so that some aspects of this work can be carried out by Alan in the future.

Enquiries are ongoing to establish how best to recycle glass across all allotment sites, with the most recent contact being an email sent to the Secretary of State for Environment. Alan is hitting stumbling blocks each time but not giving up that there must be a better option than landfill. This expands on the window frame recycling recently progressed across some sites. Alan has welcomed new plot holders at both Hirst East End and North Seaton Colliery and has had some very positive feedback from new allotment holders. With the weather much improved and plot holders getting on with their gardens, and lots of jobs on site, Alan is a very welcome and visible presence.

Further taps repairs have been carried out at our Woodhorn Road Site.

We continue to collect rents due from 1<sup>st</sup> April for Nursery Park, and Hirst East End. We are pleased with the increase in allotment holders paying direct into the bank.

From Monday 7<sup>th</sup> April, notice has been given by DEFRA that it is a legal requirement for all bird keepers across the county to keep their birds housed due to avian flu in Northumberland – whether they have pet birds, commercial flocks or just a few birds in a backyard flock. This is in addition to existing requirements for strict biosecurity measures to be put in place to help limit the spread of the disease and keep flocks safe, which includes regularly cleaning and disinfecting equipment, clothing and vehicles when entering or exiting sites and limiting access to non-essential workers or visitors.

Notices have been put up at all Allotment sites. Since October 2024 all keepers of birds are required by law to register, therefore all those who have complied will have been notified directly about the outbreak and what they should do.

# **Great British Spring Clean**

The Great British Spring Clean 2025 campaign was successfully conducted in Ashington with events on Thursday 27th March at People's Park and Friday 28th March at Wansbeck Riverside Park. Unfortunately, the planned third event scheduled for Saturday 29th March had to be cancelled due to insufficient participation.

Over the two active days, more than 20 volunteers participated in the clean-up efforts. Participants included local residents, staff from Cooplands Bakery, young adults from Brightside Young Adult Services, and staff and volunteers from Northumberland Community Voluntary Action. The community spirit was further enhanced by The Wansbeck Pantry, who kindly provided free tea and coffee to volunteers following the riverside litter pick.

Jimmy France from LukLuk Productions documented both events, with the resulting footage now available for viewing on the town council's YouTube channel, website and Facebook page. Northumberland County Council supported the initiative by removing all collected waste. Additional litter picks were independently organised and carried out by children from Cleaswell Hill School at Hirst Park, and members of the Seaton Vale Residents Association, further extending the reach and impact of this year's campaign.

All team members contributed significantly to litter picking efforts and to making volunteers feel rewarded and appreciated.

Plans are progressing well. The events page has been updated with all confirmed participants and their activities.

The fair will feature a comprehensive program including musical performances, talks, video screenings, a Hack-a-thon, and a school climate change poster display. We've also arranged a local produce market offering a diverse selection of goods, with only a few stalls still available.

## Easter Trail - Bunny Hop

Starting this Friday the bunny hop, in its third year, now includes event more shops and traders – 26 in total. Gary is continuing to work hard to get more of our local traders involved in the Council's endeavours – it requires boots on the street and is time consuming, but it seems to be working. Gary has also shopped around to get the best deal on easter eggs, and these will be given out to those who have taken part at the ECO fair – encouraging attendance that way also.

Progress has been made on the area enhancement project, with some amends due to top soil not being available when the contractor was on site.

NCC have now removed the rockery and flags as planned.

- Mark and Ryan have removed the old seats and bin and installed the new bin. Seats are on order.
- ➤ Brambledown have installed new paving and shaped the rear shrubbery. It was expected that Brambledown would install two small round beds and plant up 30 plants, buddleia and hebe. As the top soil was stalled, the plants are being looked after in our greenhouse at Hirst Park, and Mark and Ryan will install the beds when this can be progressed. This means the size and shape of the beds can be altered, but we must remain mindful that these should be low maintenance as NCC are responsible for this. Mark has liaised with NCC will draft plans to show ward Clirs.

# Workers Memorial - St John's Cemetery

Work by Mark and Ryan will be completed hopefully by the end of this week, but definitely by 28<sup>th</sup> April, which is Workers Memorial Day. NCC Cemeteries staff have some works to complete on the paved areas which Mark is seeking a date for.

Mark has gone above and beyond to add value and meaning to this project, which will be evident once it is complete. All publicity in regards this project will be shared post-elections.

Following agreement last month, the gate has now been fabricated locally and will be installed when this can be scheduled.



The initiative follows previous successes such as free swim sessions at Ashington Leisure Centre, which were introduced based on youth feedback. A new promotional video has also been released to highlight the benefits of the swim programme. The survey is open now and will help shape future youth-focused services and activities.

# Civic Head Visits Escape Family Support To See Impact Of Town Council Grant

Our grant of £3,000 to ESCAPE Family Support earlier this financial year, helping the charity continue its vital work with Ashington families. Civic Head Cllr Caroline Ball visited ESCAPE to see the impact of the funding, which supports core services such as 24/7 helplines and accredited training. In 2023/24, 15% of ESCAPE's service users were from Ashington, with most families reporting improved wellbeing. The Town Council's support has helped the award-winning organisation meet rising demand and continue making a real difference in the community.

# <u>Ashington Town Council Supports Newbiggin Football Club with Grant for Volunteer Training and Pitch Maintenance</u>

Our small grant awarded a grant to Newbiggin Football Club to support volunteer training and pitch maintenance. The funding will go towards line paint for the pitches and enrolling volunteers in Level 1 and 2 Grounds Management Association courses. This investment in skills and facilities will ensure high-quality playing conditions and long-term sustainability for the club, which plays a key role in the community. Civic Head Cllr Caroline Ball presented the grant and praised the club's commitment to grassroots football.

# <u>Ashington Town Council Supports Bomarsund Welfare Cricket Club's Initiative for New</u> Changing Room Facilities

Our small grant to support Bomarsund Welfare Cricket Club with a grant to improve changing room facilities at Stakeford & Bomarsund Welfare. She noted that even the CEO of Advance Northumberland, who had initially doubted the severity of the property conditions, offered an apology after witnessing them firsthand. She recommended verifying reports on the Fix My Street platform due to the sometimes-lengthy response times from Northumberland County Council.

Cllr Lynne Grimshaw reminded the committee that from 1<sup>st</sup> May, a new council and board will be established, noting that priorities will need to be determined once this transition is complete.

Cllr Pauline Thompson expressed frustration at having raised the same concerns for 20 years, emphasising the urgent need for effective landlord legislation and penalties for backyard accumulations, which she described as dangerous fire hazards.

Cllr Caroline Ball mentioned that the CVS had organised a photographic exhibition featuring the Hirst area, which was subsequently displayed at County Hall to significant displeasure from County officials due to the poor state of the area depicted.

Cllr Marjorie Chambers highlighted that Fix My Street response times can extend to 76 hours. She also raised concerns about street sweeping operations, particularly on the Main Street, noting that the number of operatives has been reduced from six to five.

Councillor Caroline Ball commented that landlord licensing would be ineffective without proper enforcement mechanisms, as current regulations fail to prevent waste accumulation by landlords.

Cllr Louis Brown acknowledged the committee's shared frustration, noting that insufficient staffing and resources continue to hamper progress. He suggested allowing the incoming Council to attempt to make meaningful improvements.

Cllr Paul Wright discussed the exhibition and proposed drafting a formal response regarding the inappropriate representation of the town. The Executive Officer advised that a better understanding of the exact details of the photography should be done prior to any formal response, noting that the photography may have had a specific theme.

Cllr Caroline Ball suggested that the new Council should implement a positivity campaign to highlight and promote the favourable aspects of Ashington.

Cllr Marjorie Chambers inquired about the duration of the exhibition in the CVA window and whether its removal could be requested. The Executive Officer repeated that more information was needed, which would be sought the following day.

Cllr Pauline Thompson shared an account of following a street sweeper vehicle, observing that it merely circulated through Ashington without performing any actual sweeping before returning to the depot. This occurred despite assurances during a partnership meeting that vehicles were equipped with tracking devices. She recommended verifying whether these trackers are operational and monitoring performance effectively. The Executive Officer confirmed that sweepers would not have sweepers down if their load was at capacity.

Cllr Glynn Davies alleged that other towns, specifically Cramlington and Morpeth, receive preferential treatment under the Partnership scheme. The Executive Officer clarified that Cramlington do not have a partnership agreement.

Cllr Louis Brown concluded that if these issues persist, the council should consider withdrawing from the partnership agreement.

## FGS25/129 DOG FOULING IN ASHINGTON

This item was raised by former Cllr Gemma Hemsley and Cllr Mark Purvis. The meeting received a report on dog fouling and the enforcement measures in place as provided by NCC, including actions to address dog fouling in Ashington, engagement with NCC to improve enforcement and awareness efforts.

## Key Points including:

- CCTV Limitations: CCTV footage cannot be used as direct evidence for issuing fines due to proportionality concerns raised by NCC Legal under current regulations.
- Available Enforcement Options: CCTV can be used indirectly to identify problem areas and guide patrol patterns.

- Informal warning notices have been given as deterrents by ATC Officers when we are aware of culprits.
- Pavement markings have proven effective as preventative measures in other areas and will be used in Ashington.
- Enforcement Challenges: Officers lack powers of detainment.

Statistics: Between January 2024 and February 2025, 107 dog fouling complaints were received in Ashington with no Fixed Penalty Notices issued and only five warning letters sent.

## Proposed Actions include:

- Direct NCC patrols to problem areas
- Implement pavement marking in hotspots
- Explore community education initiatives
- Consider engagement with NCC's Green Dog Walkers program

Cllr Caroline Ball questioned the effectiveness of dog warden officers, expressing concern about their inability to utilise CCTV footage or properly enforce the regulations they are tasked with upholding.

Cllr Marjorie Brown recalled a previous initiative where a substantial enforcement team was deployed on the main street to address cigarette littering issues. She noted that a personal acquaintance had received a £75 on-the-spot fine for discarding a cigarette. She suggested that Northumberland County Council should implement similar enforcement measures in known problem areas for dog fouling.

It was AGREED to note the report.

# FGS25/131 CLOSED CIRCUIT TELEVISION (CCTV) MEETING, 5<sup>TH</sup> March 2025 The report was RECEIVED and NOTED.

The Executive Officer informed the committee that a problematic area has been identified behind Bubbles Bar. She reported that while the light stand at this location is currently non-operational, once repairs are completed, a camera will be installed at the site to monitor activity.

#### FGS25/132 EXCLUSION OF PRESS AND PUBLIC

It was AGREED the press and public be excluded from the meeting during consideration of the following item, permitted under Section 1 (2) LGA 1960, due to the confidential nature of the business being transacted. The matter is commercially sensitive.

#### **FGS25/133 FESTIVE LIGHT PROCUREMENT**

The outcome of the tender evaluation process was **CONSIDERED** and the appointment of a supplier for the supply, installation, maintenance, and storage of festive lighting displays was **AGREED**.

The Council initiated a procurement process to identify a preferred supplier for the Festive Lighting. This process included issuing an invitation to tender, receiving and reviewing

submissions, evaluating the proposals based on agreed-upon criteria, and conducting presentations to the evaluation panel.

Proposals were assessed against several weighted criteria, including Experience (20%), Proposed Scheme Approach (25%), Technical Ability (20%), Quality and Sustainability (20%), and Presentation (15%).

The evaluation panel consisted of Cllrs Louis Brown, Marjorie Chambers, and Pauline Thompson, alongside officers Sarah Eden, Mark Air, and Sharon Parmley.

Five contractors submitted proposals and were shortlisted to deliver presentations. Two additional contractors conducted site visits but ultimately did not submit proposals.

Following the evaluation process, the panel recommended Blachere Illumination as the preferred supplier for the Festive Lights under a five-year contract.

Beyond scoring highly in the evaluation, Blachere's presentation particularly impressed the panel by demonstrating a commitment to building upon existing displays, extending lighting into public areas around the bus station, and offering the adaptability needed to reflect ongoing changes in the public realm and local development.

Financial implications will be addressed as part of these discussions, with costings to be developed in line with the Council's agreed annual budget of £41,000.

The meeting resolved to formally approve Blachere Illumination as the preferred supplier for the provision of Christmas Lights for the town. Members authorised the Executive Officer to enter detailed negotiations and discussions with Blachere Illumination regarding the specific terms and conditions of the contract.

Cllr Glynn Davies inquired whether the committee could proceed with implementation or if ratification from the Full Council would be required. The Executive Officer confirmed that Christmas Lights were within the remit of the Finance and General Services Committee.

Cllr Pauline Thompson noted that the selection of the preferred supplier for the Festive Lights was straightforward, with a clear frontrunner among the candidates.
