The written report copied below was issued with the agenda. Members were invited to ask any questions of the Clerk or Officers present. There were no questions received.

Neighbourhood Services

We have welcomed Matthew to the team, and he is working with Ryan on horticulture and assets.

The Executive Officer has created a schedule for our assets and horticulture that defines the jobs expected to be carried out across the week, depending on high or low season. This is scheduled work and there is some time available for reactionary work. This coincides with the introduction of the new asset platform CiviCLY that all staff have been introduced to and which is working well and will make managing our assets much more efficient.

Prior to horticultural assets being worked through on the weekly high season visit more substantial work has been carried out on each. This includes the Memorial Garden, Doves Corner, St. John's Workers Memorial, the Mining Wheel, Jack Charlton Statue, and the four Gateways. Station Road beds are underway as we speak. It is expected that by w/c 15th June we will move to the routine schedule.

We have suffered vandalism at both Alexandra Road Play Area and People's Park Play area recently. People's Park is a concern, and damage is currently being assessed, as well as the CCTV footage available to try and ascertain who is responsible.

The projections for the world cup are on so we hope they will pick up some positive comments as England proceeds through the competition.

Town Twinning

The delegation of all twin towns and cities is being held in Remscheid in April 2027, planned for 8-10th April. Along with Newbiggin-by-the-Sea Town Council, Ashington Town Council is cordially invited, and the Executive Officer had an informal online meeting with Sven Wolf, Lord Mayor Remscheid prior to the Annual Meeting. Remscheid is celebrating 20 years of their Youth Council which we hope will be a feature of the trip. They are keen to look into Parkrun following this suggestion. Anyone Cllr wishing to join the trip would be very welcome. The Council will be formally represented as usual by the Civic Head.

Public Toilets

Following the Council's formally agreed interest in December to seek information the public toilets on Station Road there has been no further information from NCC. The EO has sought a conversation, following up in January and again in April. This was followed up again in May after the announcement of capital expenditure on public toilets being planned in Northumberland (copied below).

Public Toilets Investment Programme

The Council has agreed an additional £1.56m capital funding in its Medium-Term Financial Plan over the next 3 years to enable the completion of its Public Toilets Improvement Programme. The additional funding will mean that all 54 public toilets in the County will benefit from improvements, with the remaining 26 public toilets being improved over the next 3 years. Details of the timing of refurbishment activity and scope of works needed at each facility are currently being developed. Issues with repeated blockages at Alnmouth public toilets have not been fully resolved following changes made to cisterns, so some further works to improve the flow/falls within the drainage pipework serving the site are due to start in June. Access to toilets will be maintained during the works.

Council Owned Depot – Community Asset Transfer

The full application was submitted at the end of February. After a follow-up email by the Executive Officer, further documents were requested and subsequent to some back and forth the full application was signed off as received on 22nd April. This is now at Stage 2 for assessment by the Strategic Property Asset Management Group (SPAMG). There are no published timescales for a response; an update has been requested.

Website

Ashington Town Council has completed a major overhaul of its website, delivering significant improvements to accessibility, navigation, and functionality. The project has involved extensive redevelopment across the website's key sections, with work on smaller areas still ongoing. The Wards section now features a faster, more accessible interactive map, allowing residents to view ward information, identify their local councillors and use a postcode search to locate their ward quickly. The Policies section has been completely redesigned, enabling users to search for specific policies, sort documents more effectively and see clearly when policies were last adopted and updated. The Councillor's page has been enhanced with new search and sorting

functions, making it easier for residents to find and access information about their elected members.

The Structure and Committees section has been transformed from a lengthy text-based page into a clearer, easier-to-navigate format. The Allotments section now offers integrated directions for both Android and iPhone users and incorporates the same interactive mapping system used in the Wards section. Several information pages, including the War Memorial and About Ashington Town Council sections, have been redesigned to improve readability, replacing large blocks of text with a more engaging layout.

The mobile version of the website has received substantial improvements, with a dedicated navigation system making browsing significantly easier on smartphones and tablets. Smaller standalone pages covering items such as seats, bins and bus shelters have been brought together under a new Street Scene section, creating a more logical structure for residents. The Community Guidance and Defibrillator sections have also been upgraded, with the latter now featuring an interactive search tool allowing users to locate the nearest publicly accessible defibrillator by current location or chosen address.

Councillors, residents, community groups, and visitors are encouraged to explore the updated website and share their feedback. Anyone who spots an issue or has suggestions for further improvements is welcome to contact the Council directly.

Facebook

The Council's Facebook page has seen exceptional growth over the period 8 May to 4 June 2026, with significant increases recorded across all key metrics compared to the previous reporting period.

Views reached 184,300, an increase of 207.2%, with 70% of views coming from non-followers, up 50%, demonstrating that content continues to reach well beyond the existing audience. Unique viewers totalled 38,476, up 174.6%. Content interactions reached 1,500, up 101.8%, with interactions from non-followers rising by 189.1% to 740, narrowly exceeding the 749 interactions recorded from followers. Facebook visits totalled 2,500, an increase of 97.5%.

The page recorded 61 new follows, up 79.4%, against 26 unfollows, delivering a net gain of 35 followers, representing a 75% increase on the prior period.

Overall, this reporting period represents a strong performance across all areas, with particularly notable growth in reach beyond the existing follower base, suggesting that content is resonating with a broader audience across the town and beyond.

Free Swim Sessions

Two free swim sessions were scheduled during the May Half Term holiday period:

Each session offered up to 80 slots on a first-come, first-served basis with no advance booking required.

The Free Swim programme continues to make a positive impact in the Ashington community. Attendance during the May holiday sessions was strong, demonstrating clear local demand for accessible leisure provision.

A further 12 sessions are planned for the summer holidays. The initiative remains on track to provide accessible, free leisure opportunities to a growing number of families throughout the year.

The initiative supports the following strategic goals:

- Promote active and healthy lifestyles across the community
- Increase access to leisure facilities for residents of all ages and abilities
- Inspire the next generation of swimmers — from learning to swim to taking skills to the next level
- Support health and wellbeing across the community through low-barrier leisure provision

Ashington Town Council has confirmed its continued funding and commitment to the Free Swim initiative for 2026. This ongoing support reflects the Council's dedication to health, wellbeing, and equitable access to leisure facilities for all residents.

Great Big Green Week Event Tuesday 9th June 2026

Ashington Town Council's Great Big Green Week event was held on Tuesday 9th June 2026 at Ashington Market, Station Road, as part of the national Great Big Green Week campaign. The free community event ran from 10am to 2pm and brought together five local partner organisations to share sustainability advice, showcase green projects, and inspire residents to take action on climate change. Over 100 members of the public visited the stalls throughout the day, making it a resounding success.

The event attracted strong footfall, with over 100 members of the public visiting the stalls across the four-hour period. While the event primarily drew Ashington residents, visitors also travelled from Bedlington, Morpeth, Blyth, and Newbiggin to attend. Every stall saw excellent levels of engagement throughout the day, with many visitors commenting that they had genuinely benefited from the wealth of information and advice on offer.

Five organisations participated in the event, each offering tailored advice and engagement:

Citizens Advice Energy Team — provided energy advice and information to help residents reduce their bills and carbon footprint.

Climate Action Wansbeck — ran a popular 'swap pledges for plants' activity, encouraging residents to make green commitments.

Groundwork NE & Cumbria — showcased green projects, volunteering opportunities, and recycling advice.

NCC Climate Change & Warmer Homes Team — offered advice and information on home energy efficiency improvements.

Full Circle Food Project — held a plant sale and shared information about the project's work in the local community.

Ashington Town Council — provided information on climate change projects in the town and hosted the free raffle.

The popular free raffle for energy-saving appliances proved a highlight of the day. Two lucky winners were drawn: Audrey from Ashington won the air fryer (ticket Green 246–250), and Yvonne from Ashington won the slow cooker (ticket Pink 256–260). Both winners were delighted with their prizes.

A community Questionnaire invited residents to submit ideas for small green projects that could benefit Ashington. The response was outstanding, with suggestions including:

- Community allotments and growing areas
- Communal composting schemes
- Greater support and infrastructure for recycling
- A demonstration allotment to inspire and educate the community
- An Eco Hub for Ashington
- A Repair Café to reduce waste and extend the life of everyday items

All suggestions will be considered by Ashington Town Council's Climate Change Committee as the Council continues to develop its green agenda for the town.

Northumberland Environment and Climate Fund (NECF) Celebration Event County Hall Friday 12th June 2026

Alan Bunker and Sharon Parmley attended the NECF Celebration Event at County Hall, where 9 of the 14 projects from last year were represented. It was great to see the breadth of work taking place across the county to tackle climate change, including river and nature projects, heating system upgrades to reduce carbon footprints in buildings, and recycling initiatives.

Sharon delivered a short presentation on the Eco Fair, which was held in April 2026, accompanied by a 5-minute highlight reel edited by Gary Holmes from the full 20-minute video.

A video message from Glen Sanderson was shared, congratulating all groups on the success of their projects. The Chair of Northumberland County Council also attended, thanking everyone for their efforts and providing an update on the Council's own work to address climate change.

This included the installation of solar panels with EV charging in the car park, the provision of NECF funding, collaboration with a range of organisations on wider projects, and the ongoing delivery of the Climate Change Action Plan 2024–2026.

Looking ahead, plans are progressing to develop an environmentally accessible allotment plot, supported by a £5,000 award from this year's NECF fund.

Northumberland Miners' Picnic Memorial Service Woodhorn Museum, Saturday 13th June 2026

The Northumberland Miners' Picnic Memorial Service took place on Saturday 13th June 2026 at Woodhorn Museum, commencing at 10:30am. Over 200 people attended the service, which is believed to be the most well-attended in the event's long history. Despite a brisk and windy morning, the sunshine held throughout. Following the service, the Northumberland Miners' Picnic continued for the rest of the day, with approximately 2,000 people attending the wider activities and entertainment.

The service was led by Ministers of Ashington & Newbiggin Churches Together and opened with a welcome and a performance from Brass Marras, who played "When the Stars Begin to Fall." The congregation then joined in the hymn "Abide with Me," followed by a Bible reading and sermon. Prayers were offered before the Ashington & District Male Voice Choir performed two pieces — "Woodhorn Disaster," which names all 13 miners who lost their lives in the 1916 Woodhorn Colliery disaster, and "Requiem." Their performance was described as deeply moving by many in attendance.

Wreaths were laid by a wide range of dignitaries, elected representatives, trade union officials, and community organisations, reflecting strong cross-community support for preserving Northumberland's mining heritage.

A blessing was given before the closing address which was delivered by Mr Ian Lavery MP for Blyth & Ashington.

Following the service, the Miners' Picnic continued throughout the day with a full programme of live entertainment and a wide range of family activities, including crafts for children. Approximately 2,000 people attended across the day, reflecting the continued importance of the event as one of the most valued and cherished occasions in Northumberland's community calendar. Ashington Town Council extended thanks to Woodhorn Museum for providing the setting; Ashington & Newbiggin Churches Together for leading the service; the Ashington & District Male Voice Choir and Brass Marras for their musical contributions; all dignitaries and union representatives; and every volunteer, organiser and member of the public who attended and supported the day.

FGS2627/006 CCTV MEETING, 20th MAY 2026

The report was **RECEIVED** and **NOTED**.

The Clerk updated the meeting on Anti-Social Behaviour and incidents recorded by the Police at People's Park. The following update received from Inspector Wayne Daniels was shared:

I've reviewed our data and can confirm there have been 20 incidents reported in relation to People's Park over the past 8 weeks: none in April, 12 in May, and 8 so far this month.

Breaking that down:

- 10 relate to ASB: 2 x youth ASB, 6 x motorcycle ASB, and 2 x car-related ASB
- 5 are public safety incidents: 3 x accidental 999 calls, 1 x report of a suspicious person (not actually linked to the park), and 1 involving youths setting fires
- 4 crimes were recorded at the park, although only one is directly relevant — the public order offence reported by Councillor Amery
- 1 transport incident, which should really have been recorded as motorcycle ASB

Overall, 13 of the 20 incidents are relevant to the ongoing concerns. While the numbers remain fairly low, there has been a noted increase recently compared to previous months, and I appreciate there is likely some level of underreporting.

In addition, the female driver of the red vehicle was visited yesterday and issued with a Section 59 warning. She was very apologetic and clearly upset, so hopefully that message will filter through to others.

Cllr Green asked if the Paddock Wood camera now operational following this being offline. The Clerk confirmed that it was.

FGS2627/007 ANNUAL GRANTS 2026/27

The recommendations of the Grants Working Group were received. The Chair indicated that they would go through each in order, noting that there were tabled amendments in respect of two.

Ashington Cricket Club (at Welfare Rugby Club)

It was **AGREED** to fund Ashington Cricket Club (at Welfare Rugby Club) - £4,392.

Ashington Colliery Band

It was **AGREED** to fund Ashington Colliery Band - £5,000.

Ashington Cricket Club (Kenilworth Rd)

Cllr Coyle proposed an amendment, which was seconded, to award the Cricket Club the full £3,500, noting that the club was part of the town and its heritage. The proposal acknowledged that County Caroline Ball had confirmed she would use her Members Local Improvement Scheme (MLIS) funding to make-up the shortfall, but made clear the full amount of asking should come from the Town Council.

A vote was taken with a firm majority voting in favour of the amendment. It was **AGREED** to fund Ashington Cricket Club (Kenilworth Rd) - £3,500.

Ashington Hirst Running Club

It was **AGREED** to fund Ashington Hirst Running Club - £1,355.

Ashington JW Rugby Football Club

It was **AGREED** to fund Ashington JW Rugby Football Club - £5,000.

Ashington Veterans & Elders Institute

It was **AGREED** to fund Ashington Veterans & Elders Institute - £3,400.

Blossoming Communities

It was agreed not to fund the project. In view that this was the second year the organisation, based in Blyth, has not been funded, it was agreed the Clerk should meet with them and find out more about their work in Ashington.

Citizen's Advice Bureau

It was **AGREED** to fund Citizen's Advice - £5,000.

Cambois Rowing Club

It was **AGREED** to fund Cambois Rowing Club - £5,000.

Escape Family Support

It was **AGREED** to fund Escape Family Support - £5,000.

First 4 Darts

It was **AGREED** to fund First 4 Darts - £4,700.

Full Circle Food Project

It was **AGREED** to fund Full Circle Food Project - £5,000.

Green Lane Disabled and Able-Bodied Archers

It was **AGREED** to fund Green Lane Disabled and Able-Bodied Archers - £5,000.

n) Mortal Fools

Cllr Coyle tabled an amendment to award Mortal Fools the full £5,000 requested; this was seconded. The proposed amendment cited their significant contribution to the community and to young people.

Debate ensued in relation to the high level of funding received by Mortal Fools from other agencies. A vote was taken with a firm majority voting in favour of the amendment. It was **AGREED** to fund Mortal Fools - £5,000.

Following the vote clarity was sought on whether the additional funding would come from the Youth Fund, or Annual Grants, as this was relevant to further proposals on the agenda.

As the seconder, Cllr Amery confirmed his agreement that the funding should come from Youth Funding budget; this was agreed by Cllr Coyle as the proposer. Members voted again and the majority supported the motion that the full award be taken from the Youth Funding budget. Cllr Amery confirmed his agreement that the funding should come from the youth budget, and Cllr Coyle agreed to amend his amendment accordingly.

It was further **AGREED** to fund Mortal Fools - £5,000, funded from the youth budget.

Pride Action North

Cllr Brown proposed an amendment to fund the organisation at £4,000, with further information sought on activities in Ashington. There was no confirmed seconder.

Cllr Ball proposed an amendment to fund £2,000 with the remaining £2,000 held in reserve pending further discussion with Pride Action North. There was no confirmed seconder.

Debate ensued on the original motion to fund £2,000. The Executive Officer commented that the application had been of good quality overall, with the only shortfall being that the organisation delivered only one session per month in Ashington.

It was **AGREED** to fund Pride Action North - £2,000. **It was also AGREED** the Clerk should meet with them and find out more about their work in Ashington.

It was **AGREED** to fund Woodhorn Narrow Gauge Railway - £2,200.

YMCA

It was **AGREED** to fund YMCA - £5,000.

FGS2627/007 ADDITIONAL ONE-OFF FUNDING FOR WANSBECK VALLEY FOODBANK AND NORTHUMBERLAND CITIZENS ADVICE (placed on the agenda by Cllr John Tully)

Cllr Coyle tabled an amendment that the underspent balance of the annual grant be transferred from the grants budget to the youth budget, this was seconded.

Cllr Ball, as Chair of the Youth Committee, noted that funds remained available within the youth budget and suggested that the underspend should instead be moved into an open fund for a specific focus, as outlined in the next agenda item.

Cllr Tully stated that this was a matter of priorities, and that while youth provision was important, funds remained within the youth budget, whereas the two organisations highlighted under this

proposal existed to support the most vulnerable members of society. He noted that the Foodbank and CAB already provided support during the winter months.

The Executive Officer advised that, procedurally, this would be treated as a one-off arrangement, noting Cllr Ball's concern that other organisations may be unhappy if it appeared that two organisations had been hand-picked to receive the remaining grant funding. Cllr Tully reiterated that a key priority was supporting the neediest, and that funding these two organisations achieved this aim. Cllr Amery stated that, while both organisations carried out excellent work, they also held substantial reserves, and that the proposal ran contrary to the decision of Full Council which had established the £5,000 cap, undermining the rules set out by the Council.

Cllr Brown stated that this remained a matter of priorities, noting that many organisations had already been funded and that sufficient funds remained to support the groups as set out in the original proposal. He stated that CAB and the Foodbank were two of the most important organisations in the town and, while they held substantial reserves, they supported Ashington and the Council should in turn support them.

The tabled amendment to transfer the underspend into the youth budget was voted on and the amendment was carried.

The Clerk confirmed that following funding requests of £88,847, the Council had **agreed funding awards of £76,547**, with £46,847 from Annual Grants and £29,700 from Youth Funding. **It was also agreed** to move the balance in Annual Grants of £8,153 to Youth Funding.

FGS2627/008 SECOND ROUND OF ANNUAL GRANTS 2026/27 – WINTER WARM HUBS AND WINTER COMMUNITY ACTIVITIES (placed on the agenda by Cllr Caroline Ball)

Due to the previous item transferring the underspend into the youth budget, the item was not heard and considered 'fallen.'

FGS2627/009 FUNDING THE ESTABLISHMENT OF A JUNIOR PARKRUN FROM THE YOUTH BUDGET (placed on the agenda by Cllr Caroline Ball)

Cllr Ball advised that, building on the success of the existing parkrun, there was a proposal to establish a junior parkrun, to be based at Hirst Welfare; the nearest being in Blyth. Cllr Ball explained that the request was for a one-off payment to cover set-up costs, including a defibrillator and training, and noted that those involved included members of the running club and local doctors. Cllr Ball stated that the funding would leave a legacy.

In response to a question regarding the sharing of resources with the already operating Parkrun in Ashington Woods, Cllr Ball confirmed this was not possible and that the parent body who approve Parkruns are strict on rules and regulations which do not support sharing resources.

It was **AGREED** to fund the establishment of a junior Parkrun at Hirst Welfare.

FGS2627/010 SMALL GRANT AWARD INCREASE TO £1,000

It was AGREED to approve the increase of small grant funding to £1,000 in a bid to attract more applications.

Cllr Wright asked whether, in the context of increased grant funding, this would be accompanied by increased checks and measures, as is the case for annual grants. **It was AGREED** the small
